SUMMARY OF CAMPGROUND RULES AND REGULATIONS

- 1. All fees are due daily and upon entry to the park. Check-in time for campground reservations is 2:00 p.m. Check-out time is 12:00 p.m. the following day. Those occupying a campsite past the 12:00 p.m. check-out time will be required to pay for an additional night's stay. Those arriving prior to 2:00 p.m. are allowed to use their reserved site if it is vacant. Any camping unit entering the campground prior to 10:00 a.m. will be charged for the previous night's stay.
- 2. Weekend reservations (Friday Sunday) require a minimum two (2) night stay. Reservations made during Memorial Day, 4th of July and Labor Day require a minimum three (3) night stay.
- Westgate Landing only Reservation check-in begins at 2 p.m., park gates close at either 7 p.m. (November February) or 9 p.m. (March – October). Once closed, gates will not reopen until 8 a.m. the following day, no in-and-out privileges. Please plan arrival accordingly.
- 4. Quiet hours are from 10:00 p.m. to 6:00 a.m. and is STRICTLY ENFORCED. No Generators, radios, televisions, or other equipment allowed during quiet times. Indoor use of equipment may be used but must be kept at volume as to not to disturb other quests. At any time, noise which creates a disturbance or interferes in any manner with other guests' enjoyment of the park will not be tolerated.
- 5. Requests for campground reservations must be made in advance with the Park Office by calling (209) 953-8800, option 1, Monday thru Friday 8:00 a.m. to 4:15 p.m. Online reservations can be made at <u>www.sjparks.com</u>. Reservations must be made and paid for prior to entering the campground. Camping on a first come, first serve basis is not allowed. There are no refunds on reservation date changes or cancellations.
- 6. Laws are enforced by the San Joaquin County Sheriff's Department. Extra vehicle and pet fees not included in campground reservations must be paid daily in the self-payment envelopes and deposited in the Campground area self-payment station. Park staff will confirm payments, Campground Host does not collect fees nor make change.
- 7. The camping stay limit within the County Park system is ten (10) days in any consecutive twenty-five (25) calendar day period.
- 8. Campground visiting hours are from 8:00 a.m. to 10:00 p.m., visitors arriving after 9:00 p.m. (7:00 p.m. at Westgate Landing November February) are not allowed.
- 9. Camping is allowed in designated campsites only. Camping is prohibited in "Day Use" areas. No vehicle camping.
- 10. Campsite parking is limited to either a) one (1) RV and towed vehicle, b) one (1) vehicle and towed trailer or c) two (2) vehicles and must be completely contained within the designated parking space. Maximum total length is up to 50 feet at **Dos Reis** and up to 35 feet at **Westgate Landing**. No parking on lawn areas.
- 11. Campsite occupancy may not exceed eight (8) persons, including children.
- 12. Campsites and camping units must be well maintained and present a clean and pleasing appearance.
- 13. All RV, trailers and vehicles must be in good working condition with all windows, doors and sewer/water gaskets intact. Each must have valid registration and insurance, proof of registration and coverage may be requested at any time. Inoperable watercraft, unlicensed or inoperable motor vehicles or other items, which may be deemed a nuisance by the Campground Host, are not permitted. RV's and trailers are not allowed to be towed in and dropped off., tow vehicles must remain at the campsite throughout the reservation stay.
- 14. There is a two (2) tent limit per campsite. Due to park irrigation and maintenance, **Dos Reis** tent camping is limited to weekends only, from 2 p.m. Friday to 12 p.m. Monday. **Westgate Landing** tent camping is allowed seven (7) days per week.
- 15. Shower facilities at **Dos Reis** are only available from 8 a.m.-10 a.m. and 6 p.m.-8 p.m. daily. There are no shower facilities at **Westgate Landing** and **Stillman Magee**.
- 16. No person under the age of eighteen (18) years old may camp in designated campgrounds except when accompanied by a parent or guardian.
- 17. Campers and their guests are asked to use paths and roadways, please do not walk through the campsites of others.
- 18. Vehicles cannot be parked in the Day Use areas overnight unless authorized by the Director and are subject to being towed at the owner's expense. Vehicles are limited to designated roads, speed limit is 5 mph.

FEES

- Campsite fees at Dos Reis Campground are: Camping unit one (1) motorized recreational vehicle or one (1) vehicle plus non-motorized trailer, \$35.00 per night. Camping Unit (tent) plus one vehicle, \$25.00 per night. Extra vehicles are \$5.00 (Mon. Fri.), and \$6.00 (weekends and holidays.) Pet fee is \$1.00 each pet per day (excluding service animals).
- 20. Campsite fees at **Westgate Landing Campground** are: Camping unit one (1) motorized recreational vehicle or one (1) vehicle plus non-motorized trailer or tent plus one vehicle, \$25.00 per night. Extra vehicles are \$5.00 (Mon. Fri.), and \$6.00 (weekends and holidays.) Pet fee is \$1.00 each pet per day (excluding service animals). Overnight boat dock fees are \$20.00 each slip per night. Boats that are greater than ten feet (10') wide, and twenty-two (22') long are \$40.00 each slip per night.
- 21. Campsite fees at **Stillman Magee Campground** are: Camping unit (tent, motorhome, trailer) plus one vehicle, \$25.00 per night. Extra vehicles are \$5.00 (Mon. Fri.), and \$6.00 (weekends and holidays.) Pet fee is \$1.00 each pet per day (excluding service animals).
- 22. Any additional vehicles parked in the campground for more than 15 minutes will be subject to the \$5 (Mon. Fri.), and \$6 (weekend and holiday) extra vehicle fee.

PETS

- 23. Dogs and/or cats are permitted in the County Parks if they are vaccinated and licensed. The number of pets shall not exceed two dogs and/or cats (excluding service animals).
- 24. Dogs and/or cats must be leashed and under the immediate control of their owner; they shall not be tied to trees, shelters or in a manner which prohibits access to a tent or trailer.
- 25. Dogs and/or cats shall not be left unattended nor remain outside a tent, camper or vehicle at night. The leash must be six (6) feet or less in length.
- 26. Animal excrements must be cleaned up immediately by the owner.

GENERAL PROVISIONS

- 1. No weapons and/or firearms allowed in any County Park.
- 2. No soliciting in County Parks without a permit.
- 3. All alcohol 24% or greater by volume is prohibited.
- 4. Language or behavior that is deemed offensive, derogatory or violent whether directed toward others or in general will not be tolerated.
- 5. No washing, waxing, cleaning, renovating or repairing of vehicles in County Parks.
- 6. Collection of recyclable items from park trash receptacles is not allowed.
- 7. No skateboards, roller skates, motorized model cars, airplanes, drones, boats, crafts, mini bikes, scooters, etc.
- 8. No horses or other livestock.
- 9. All trash and garbage shall be placed in trash cans. No hazardous material is to be left in the parks.
- 10. No waste water, sewage or effluent shall be deposited directly upon or into the surface of the ground or water. No fish cleaning.
- 11. No clothes lines or rope barriers are to be hung in the park. Do not use nails, screws, staples or tacks on the shelters, picnic tables, sign posts or trees.
- 12. All fires are limited to the designated fire rings and barbecues.
- 13. County of San Joaquin, its employees, agents, officers & elected officials, are not responsible for lost, stolen or damaged property sustained as a result of unforeseen circumstances, abandonment or acts of God.
- 14. All State and local laws apply on Park property.

15. Violation of any campground rule is grounds for eviction with no refunds.
